INSTRUCTIONS: Please read the following instructions carefully before filling up the online Application form:-

1. Format of Application with details of terms and conditions is available on the website of Delhi State Legal Services Authority (DSLSA) i.e. www.dslsa.org
2. Candidates are required to fill up the On-line Application form, wherein the legible scanned copies of documents are required to be attached, which is available in the Public Notice head on our official Web-site. (Note: Application in hard copy shall not be entertained).
3. The candidates shall attach their soft coloured recent photograph with the Online Application form which should not exceed 75 kb.jpg format.
4. A candidate shall submit only one application in respect of the present public notice. Multiple applications would be summarily rejected.
5. Only those candidates who fulfil the eligibility criteria may apply for empanelment. In case the Applicant/Candidate is already empanelled as Legal Services Advocate with any DLSA or DSLSA and he/she is selected in the present empanelment process, he/she would be required to resign from other panel within one month from the date of notification of result of this empanelment

process; failing which his/her empanelment with this panel shall stand automatically cancelled.

6. The candidate must fill all required particulars in the application form and no column should be left blank else the application would be rejected.
7. The applications shall be accepted w.e.f. 30.07.2018 to 13.08.2018 upto 05.00 pm. No application would be entertained after the last date.

A. ELIGIBILITY CRITERIA –

The applicant must have actual working /practice experience at Bar of least five years or more as on 01.07.2018 participating in children related issues which includes criminal inquiries and/or conducting trial of criminal nature in specific reference to Juvenile Justice System in the District Courts at Delhi including Juvenile Justice Boards and/or Child Welfare Committees at Delhi.

B. SELECTION PROCEDURE -

1. The candidates after scrutiny of applications would be called for appearing in viva-voce interview, the candidates securing highest marks according to merit list prepared by the Interview Board would be empanelled.
2. No candidate shall be called for interview unless he/she satisfies the eligibility conditions.
3. Merely fulfilling the eligibility criteria will not confer any right on a candidate to be called for interview or selection.
4. Depending upon the applications received and the requirement of DLSAs, the Authority reserves the right to short list the candidates to be called for the Interview.
5. No individual intimation will be sent to any candidate for appearing in the interview. A list of short listed candidates with the date, time and venue of Interview will be displayed on the website www.dlsa.org
6. The candidate shall bring all original documents at the time of interview.

7. Interview Board shall assess the candidates on criteria like personality/eligibility, legal knowledge /legal aptitude, commitment/ spirit to work in the field of legal aid.

C. TERMS AND CONDITIONS FOR EMPANELMENT -

1. The empanelment is purely on temporary basis. However, this empanelment shall be effective for a period of THREE YEARS or more, as per discretions of the Competent Authority, commencing from the date of notification of result. The empanelment shall be subject to review of performance/work done by each lawyer appointed by the DSLSA on month to month basis.
2. In order to ensure that there is effective check on the legal services being rendered, the lawyers on the panel must submit case wise progress every three months or from time to time. Non submission of the same would entail removal from the panel.
3. The empanelled Advocates will be paid fee as per approved Fee-Schedule of DSLSA. The nominated Legal Services Advocates shall not be entitled to any other relief/claim in excess to the fee prescribed in the Fee-schedule.
4. The empanelled Advocates shall be deployed to work at the office of the "All India Legal Aid Cell on Child Rights" at L-6, Kalkaji, New Delhi-110019.
5. The empanelled Advocates shall be paid professional fee for conducting cases assigned to them as per the schedule of the DSLSA qua such children dealt with by the Cell.
6. It will be mandatory for all empanelled Advocates to attend the training programmes and refresher courses organized by Delhi State Legal Services Authority and District Legal Services Authorities from time to time including the orientation programme to enable empanelled LSAs to handle legal aid work, as well as training to upgrade skills in various aspects of trial practice, such as the art of cross examination. Absence



from such training programmes and courses, without prior permission would be a ground for removal from panel.

7. The Authority reserves the right to avail the services of empanelled Legal Services Advocates to perform duties in Legal Services Clinics, Observation Homes, Legal Literacy Clubs, etc. and for any other activities/awareness programmes including presence in the functions to be organised by the Authority.
8. **Removal from Panel:** If performance of the Legal Services Advocate is found unsatisfactory or the Advocate is found to be guilty of charging or collecting or demanding any remuneration from an aided person in any form or he/she contravenes the Scheme of the Act, Rules and the Regulations he/she can be removed from the panel and shall also be liable for action for professional misconduct as per Regulation 7 of the Delhi State Legal Services Authority Regulations, 2002.
9. The Authority reserves its rights to enlarge/modify the scope of the duty of the Legal Services Advocates in order to achieve the aim and object of The Legal Services Authorities Act, 1987 and its Rules, Regulations and other schemes formed there under.
