It is necessary to prevent financial burden on the contesting candidates. The amendments and the Election Conduct code will empower to debar the contestants and cancel their candidature, those who do not follow the Code of Conduct.

Further, appropriate Chamber/Seat allotment rules have to be incorporated in the constitution of NDBA, so that, there will not be any irregularity in chamber allotments.

In view of the above, it has been resolved to prepare a draft for the amendments in the constitution of New Delhi Bar Association and to initiate reforms in the Elections of Executive Committee and other necessary changes.
