- Coverage under Group(Term) Life Insurance for Rs. 10,00,000/-(Ten Lakh Only) per advocate through LIC of India has been commenced w.e.f. 20.11.2020.
- Coverage under Group Mediclaim Insurance for Rs. 5,00,000/-(Five Lakh Only) with 25% co-payment through New India Assurance Co. Ltd for the registered and verified advocates, their spouse and two dependent children up to the age of 25 years has been started w.e.f. 10.12.2020

(In case of son, the coverage will be till he starts earning or till he attains the age of 25 years whichever is earlier. In case of daughter, the coverage will be till she starts earning or gets married or till she attains the age of 25 years, whichever is earlier).

In this regard, the following discrepancies have been noticed by the Insurance Companies in the particulars filled by the beneficiaries registered under Chief Minister Advocates Welfare Scheme. These discrepancies were also brought to the notice of Hon'ble High Court of Delhi in case W.P.(C) no. 3362/2020 titled Bar Council of Delhi(through its Chairman) Vs Government of NCT of Delhi.

- (i) Non availability of Gender of dependants of the applicant.
- (ii) Non availability of date of birth as per the format of Insurance Company.
- (iii) In-correct date of birth of the applicants.
- (iv) Names of many dependents are prefixed with the word "Late"

(v) Details of beneficiaries without main applicant advocate

The above particulars of beneficiaries are required for the issuance of e-cards and physical plastic cards by Health India Insurance, TPA appointed to service the Mediclaim policy on behalf of New India Assurance Co. Ltd.

In order to provide the requisite information of the beneficiaries of the scheme to the Insurance companies, Online Module of this scheme shall be opened for limited purpose only for updation/correction/verification of particulars filled by the registered beneficiaries for availing the benefits of Group(Term) Life Insurance and Group Mediclaim Insurance. This updation/correction/verification of particulars is mandatory for all the registered beneficiaries for the issuance of e-cards and physical plastic cards and for providing intimation of insurance coverage through e-mail by Health India Insurance, TPA appointed to service the Mediclaim policy on behalf of New India Assurance Co. Ltd.

All those advocates who had registered themselves under Chief Minister Advocates Welfare Scheme but their names are not reflected in the list of beneficiaries are also required to update/correct/verify their particulars on the above mentioned online module so that the benefit of the scheme may also be provided to them.
