





Secretary of NDBA vide this letter has informed that a letter dated 25.05.2018 was sent to this Committee informing clearance of dues of the twelve members named in the said letter. The name of Sh. H. N. Gupta, Advocate was also included in the list of twelve members whose dues were cleared.</p> <p>It is further informed that NDBA vide letter dated 31.05.2018 had informed the Committee that the cheque of Sh. Pratap Ranjan was also cleared.</p> <p>The Hony. Secretary has further drawn attention of the Committee to the Minutes of the Election Committee dated 04.07.2018 where it is noted that taking into account letter dated 25.05.2018 and 31.05.2018 from the NDBA, the Committee has removed objections against the members named in those letters with regard to dues. However, in the final list, it is shown that the dues are pending against Sh. H. N. Gupta, Advocate and cheque bounced against Sh. Pratap Ranjan, Advocate.</p> <p>The Committee has perused its records and resolves to correct the clerical mistake and declares that Sh. H. N. Gupta, Advocate</p>





(D/387/1983) and Sh. Pratap Ranjan, Advocate (D/4648/2010) are entitled to vote as their dues are reported to be cleared.

Considering the Minutes of this Committee dated 16.07.2018 with respect to Sh. Manish Kumar Advocate (D/216-A/2004) and decision taken today with respect to Sh. H. N.
