



1.	<p>Letter dated 23.03.2017 sent by Sh. Nagender Kumar Sharma member of NDBA on the subject "Non declaration of the Election Committee for Conducting New Delhi Bar Association Election and for finalizing the eligible voter list in obedience of Order/judgment dated 18.10.2016 in CM 36262/16 in WP (C) 8106/10 by the Hon'ble High Court of Delhi."</p>	<p>Intimation was sent to Sh. Nagender Kumar Sharma, Advocate to attend the meeting today but he is stated to be out of station today and has expressed inability to attend the meeting today.</p> <p>Sh. Nagender Kumar Sharma has stated in the letter that the Election Committee has not been formally declared by the Ld. District & Sessions Judge, New Delhi District and NDBA has also not issued any circular in this regard.</p> <p>Let the minutes of this meeting as well as minutes of earlier meetings held on 26.02.2018 and 20.03.2018 be uploaded on the website of New Delhi District Court's website and the Hony. Secretary, NDBA be also requested to upload all the minutes on the website of NDBA.</p> <p>So far as the grievance that the declarations are being sought by NDBA from members is concerned, it has come to the notice of this Election Committee that similar practice was followed in other Districts also while conducting elections to the Bar Associations.</p> <p>The other submission of Sh. Nagender Kumar Sharma is that Declaration Form cannot be altered/amended/changed and all requisite fields as directed by the Hon'ble High Court have to be incorporated in the Declarations Forms.</p> <p>The Committee has seen the Declaration Form circulated by NDBA. In that Declaration Form, all the requisite fields as directed by the Hon'ble High Court have been incorporated and additional information is also sought about name in the voter's list of Delhi Bar Council and in case the name is not in the list, the reason thereof. Further, information is also called regarding All India Bar Examination from those members who were enrolled with BCD after 2009-2010.</p> <p>The Committee is of the unanimous view that since any lawyer whose name is not in the Roll of BCD cannot be member of any Bar Association in Delhi and any lawyer who has not passed All India Bar</p>

Examination conducted by BCI as enumerated under Rule 9 to 11 in Part VI, Chapter III of BCI Rules cannot have the voting right in the election of Bar Associations, there is no irregularity in the Declaration Forms circulated by NDBA.

The Committee decided to file the letter of Sh. Nagender Kumar Sharma, Advocate.

The Committee has noticed that today a letter has been received from Dr. Sushil Kumar Sharma, Assistant Registrar (AG) informing that the registry of the Hon'ble Supreme Court has no role in conducting the election of the Supreme Court Bar Association and no record related to SCBA election is kept on record of the registry.


A letter has also been received from Sh. Vimal Kumar Yadav, Ld. Link Officer Incharge, General Branch, Additional District & Sessions Judge, Central, Tis Hazari Courts, Delhi enclosing the records pertaining to voters list with respect to the election of Delhi Bar Association.


Voters list from Dwarka Courts has also been received. Voters lists of all the Bar Associations of different courts and tribunals in Delhi as available with the Ld. District & Sessions Judge, Dwarka have also been received.




