NAME OF THE BANK: UCO BANK, PATIALA HOUSE COURTS, NEW DELHI

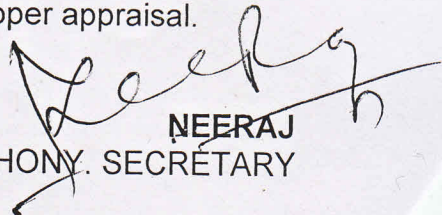
