



Correcting a clerical mistake in the final Voter's List for Elections of NDBA, 2018.	<p>1.The Committee has observed a clerical mistake in the Final Voter's List prepared by it for the elections of NDBA, 2018.</p> <p>2. Initially, in the Draft Voter's List, at Serial No.1547, the Committee has observed that Sh. Manish Kumar, Advocate is not entitled to vote as his name is not in the list of voters of Bar Council of Delhi.</p> <p>3. However, in the light of letter dated 19.05.2018 received from BCD, the member Sh. Manish Kumar, Advocate, is enrolled with BCD, and therefore, 'Entitled to Vote'</p> <p>4. But in the Final Voter's List at Serial No.437, he was shown as 'Not Entitled to Vote - AIBE Certificate Not Enclosed'.</p>





5. The Committee notices that this is clearly a clerical mistake made on its part. There is no question of Sh. Manish Kumar, Advocate requiring AIBE Certificate as he is enrolled with Bar Council of Delhi since 2004.

6. The Committee therefore, by way of these Minutes corrects its clerical mistake and declares Sh. Manish Kumar, Advocate having Enrollment No.D-216-A/2004, entitled to vote in the NDBA Elections, 2018.

7. The Committee recalls its observation that this member is not entitled to vote as he has not enclosed AIBE Certificate as the same is not required in his case.
