## CIRCULAR

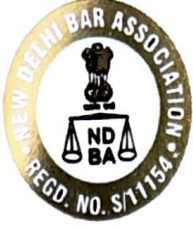
Respected members of the Bar,

Executive Committee is committed for keeping transparency, especially in the financial affairs, of the Bar. Upon completion of one year after taking charge, account status of bar funds duly certified by the Chartered Accountant is being provided herewith.

Already conveyed to the Bar, vide Circular dated 08.10.2025 along with Statement of Account, that upon assuming charge in March, 2025 effectively an amount of Rs.44,56,329/- (Rupees Forty Four lakhs Fifty Six Thousand Three Hundred Twenty Nine only), after making the payments of the liabilities for March 2025 prior to Elections, was the aggregate amount available in different Bank Accounts of NDBA besides the FDR deposits. **In six months there was an increase of approx. Rs. 20 lacs in the Bank accounts of NDBA.**

However, we are pleased to inform you that apart from FDR with their accumulated interests, an aggregate amount of **Rs. 99,13,576/-** (Rupees Ninety Nine Lakh Thirteen Thousand Five Hundred Seventy Six only) is the credit balance in different Bank accounts of NDBA as on **31.03.2026** and thus, **there is a net increase of Rs. 54,57,237/- in the accounts in one year.** It will not be

**We would also like to further highlight that:**

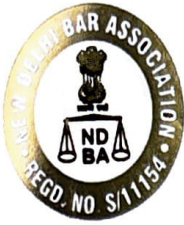
- In the last one year, there is not a single cash withdrawal or withdrawal through self cheque from Bank accounts of NDBA towards payment made to any vendor.

10. Installation of new sewer line for the toilets in Central Hall, Ladies bar Room and near Chamber No. 711.

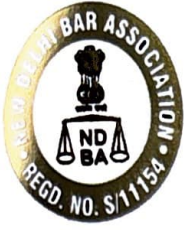
11. Completely new platforms for water near CJM Court, in the park near Chamber No.852 and in Padam Singh Block.

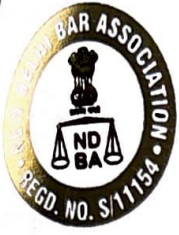
